GENERAL INFORMATION

Turf Flo® 20-0-5 Fertilizer provides recommended rates of nitrogen, and potassium with the purpose to promote vigorous turf growth and root development in recently seeded and established turf. It contains "Controlled Release Nitrogen" which provides extended, even nitrogen release while reducing burn potential on turf.

Turf Flo® 20-0-5 Fertilizer features the following:

STORAGE & BLENDING INSTRUCTIONS

Use within 6 months of the date of purchase. Store unblended in closed container between 32 and 85 degrees F. Dilute with water and blend with other nutrients at the time of application and in the amounts recommended.

TANK MIXING

On Established Turf: Add 1/2 of the total water to the tank and begin agitation. Add recommended amount of this product. Add liquid concentrate materials, followed by water-soluble materials. Fill spray tank with remainder of water and continue agitation.

Established Turf Application –To apply the applicable rate of Nitrogen per 1,000 sq. ft., use the following rates:

3/4 Lb of N.....	47.52 fl.oz.
5/8 Lb of N.....	39.60 fl.oz.
1/2 Lb of N.....	31.68 fl.oz.
3/8 Lb of N.....	23.76 fl.oz.
1/4 Lb of N.....	15.84 fl.oz.

PRECAUTIONS

Do not exceed 1 pound of Nitrogen per 1,000 square feet per application. Apply in water carrier at no less than 1.5 gallons per 1,000 square feet.

DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN, AND SWEEP ANY PRODUCT THAT LANDS ON THE DRIVEWAY, SIDEWALK, OR STREET, BACK ONTO YOUR LAWN/GARDEN.
