GENERAL INFORMATION

Pump House 9-9-9 Fertilizer provides recommended rates of nitrogen, phosphorus, and potassium with the purpose to promote vigorous turf growth as well as root development.

APPLICATION RATES

Established Turf Application – For the desired amount of Nitrogen per 1,000 sq. ft., apply at the following rates:
