GENERAL INFORMATION

VOLUTION Maxx is a flexible soil surfactant blend that allows turf managers to customize their water management and irrigation programs. VOLUTION Maxx increases the infiltration of water into the soil while uniformly holding it in the root zone over time. VOLUTION Maxx provides performance across a variety of turf and soil types.

VOLUTION MAXX IS DESIGNED FOR USE ON GOLF COURSES, ATHLETIC FIELDS AND RESIDENTIAL OR COMMERCIAL TURF, UNDER THE SUPERVISION OF GOLF COURSE SUPERINTENDENTS, SPORTS TURF MANAGERS OR PROFESSIONAL LANDSCAPE CONTRACTORS.

DIRECTIONS FOR USE

To enhance efficacy and avoid the risk of leaf discoloration caused by certain environmental conditions that may exist at application, apply VOLUTION Maxx using the application techniques described below.

APPLICATION TECHNIQUES

During weather conditions with high temperatures and/or low humidity take the following precautions:

- 1) Pre-wet the turfgrass with approximately 0.10 inches of irrigation water to reduce the concentration of VOLUTION Maxx on the leaf surface.
- 2) Following application, irrigate for 10-20 minutes to move VOLUTION Maxx into the root zone. Apply longer irrigation time if localized dry spot is already apparent.

USE RATES

Apply **VOLUTION Maxx** at 4 ounces per 1000 sq. ft. for performance up to **30 days.**

Apply **VOLUTION Maxx** at 6 ounces per 1000 sq. ft. for performance up to **45 days.**

Apply **VOLUTION Maxx** at 8 ounces per 1000 sq. ft. for performance up to **60 days.**

Apply **VOLUTION Maxx** at 8 ounces per 1000 sq. ft. in split applications, 2 weeks apart (for a total of 16 oz.), for performance up to **90 days.**

TANK MIXING

Unless prior experience has proven the combination to be effective, compatible and safe on the desired turf species, it is not recommended that VOLUTION Maxx be tank mixed with other pesticides, fertilizers, micronutrients, bio-stimulants or other such products.

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature before use. Store in original container only and do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the container in accordance with federal, state and local regulations. Do not store near heat or open flame.
