STORAGE

Store unblended in a closed container between 40 degrees and 90 degrees F.

DIRECTIONS FOR USE

Greens, Tee's and Fine Turf

Apply 8.75-11 ounces of 14-4-9, FertAminos® With 50% SCR N per 1,000 square feet (3 to 4 gallons per acre) every 7 to 14 days. This supplies approximately .10-.125 pounds of Nitrogen per 1,000 square feet. For additional plant health performance tank mix with MicroTek Micro-Nutrient Package.

Fairways, Roughs, Sports Turf and Lawns

Apply 11-17 ounces of 14-4-9, FertAminos® With 50% SCR N per 1,000 square feet (4.0 to 6.2 gallons per acre) every 7 to 14 days. This supplies approximately .125-.20 pounds of Nitrogen per 1,000 square feet. For additional plant health performance tank mix with MicroTek Micro-Nutrient Package.
