TANK MIXING

On Established Turf: Add 1/2 of the total water to the tank and begin agitation. Add recommended amount of Turflo[®]17-0-5. Add liquid concentrate materials, followed by water-soluble materials. Fill spray tank with remainder of water and continue agitation.
